



**Paulo Fohlin**, partner *Odebjer Fohlin Associates*, LL.M., Advokat, Chartered Arbitrator (C.Arb), Fellow of Chartered Institute of Arbitrators (FCI Arb).

Arbitrator and counsel in international arbitration involving common law as well as civil law disputes. Member of the Swedish Bar Association and thus “Advokat” since 1994. Registered as a foreign lawyer with the Hong Kong Law Society from 2007 to 2019. Co-founded Advokatfirman Odebjer Fohlin in Hong Kong 2011. *Odebjer Fohlin Associates* is since mid-2019 an association of the two firms Advokatfirman Odebjer Fohlin in Hong Kong and Advokatfirman Fohlin AB in Stockholm.

Paulo has experience of dispute resolution in private practice since 1988 when he joined the Swedish law firm *Vinge* fresh from law school. Before that, he also studied contracts, torts and constitutional law in the USA. He became a longstanding partner at *Vinge* until co-founding the boutique law firm Odebjer Fohlin.
