At the same time, greater scrutiny of ESG Principles by all stakeholders in a project may well lead to a array of disputes, e.g. from operator's duties to financing obligations, reporting and information rights, access to discussions with counterparties, budgeting, approvals and distributions and etc. Those disputes can be solved, either domestically or by international arbitration.

The Seminar will give a glance from different countries regarding ESG and the role that international arbitration can play in this space.

Spain is viewed by foreign companies, mostly European and increasingly also Asian companies, as a springboard for doing business in Latin America, and vice versa, for Latin American companies to get into European markets, and recently also into Africa, through Spain.

In short, Spain can play a triangle role in the field of international arbitration between Latin American and European countries, on the one hand, and between Latin America and Asia, on the other. For everything related to Latin America, Spain is a dispute resolution centre of the very first order. Spain could be a "natural forum" for international arbitration for those parts of the world.

Participants will learn about the latest development regarding ESG in Spain, and some countries of Europe (Sweden), Latin America (Chile and Mexico) and Asia-Pacific (Australia, China, Japan and Singapore) and the eventual connection with international arbitration.
